

# PrecisionPath iPad Giveaway Contest Rules



NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED BY LAW. To be eligible, you have to be a legal resident of the United States and 18 years of age and over.

By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the PrecisionPath Consortium which shall be final and binding in all respects. The PrecisionPath Consortium is responsible for the overall administration of the Contest.

The PrecisionPath Consortium giveaway of one Apple iPad begins on May 23, 2016, and ends on June 30, 2016 ("Contest Entry Period"). By participating in the Contest, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the PrecisionPath Consortium which shall be final and binding in all respects. The PrecisionPath Consortium is responsible for the overall administration of the Contest.

## TERMS

A. **ELIGIBILITY:** The Contest is open to legal residents of the fifty (50) United States including the District of Columbia. The PrecisionPath Consortium and its employees, agents, officers and directors (collectively, the "Contest Entities"), their affiliates, subsidiaries, franchisees, advertising and marketing agencies, immediate families and persons living in the same households as such individuals (whether related or not) are not eligible for the Contest.

B. **ENTRY RULES:** Enter the Contest during the Contest Entry Period designated above. The PrecisionPath survey must be filled out in its entirety to be a valid entry. Each person who registers with the Contest Site earns one (1) chance to win the Apple iPad.

C. **THE PRIZE:** The PrecisionPath Consortium will award one Apple iPad to one (1) contest entrant. The PrecisionPath Consortium will contact the contest winner to finalize their prize package. There will be no cash compensation. The PrecisionPath Consortium will not replace any lost or stolen prize items. All federal, state, local and other taxes are the sole responsibility of the applicable winner. The prize must be redeemed within one month of prize notification. Prize packages will have no value after this date.

D. **WINNER SELECTION:** The Winner will be selected in a random drawing from among all eligible entries received throughout the Contest Entry Period. The random drawing for the Contest will be conducted on June 30, 2016. The random drawing will be conducted by The PrecisionPath Consortium; all decisions are final. Odds of winning will depend on the number of eligible entries received. Winner will be notified by email within ten (10) days of the random drawing. The PrecisionPath Consortium is not responsible, and may disqualify an entrant, if the entrant's email does not work or is changed. Any winner notification not responded to within 30 days or returned as undeliverable will result in Prize forfeiture and an alternate winner shall be selected. If a potential winner is ineligible to win the Prize because of material misrepresentation, does not comply with the acceptance requirements above or is otherwise in violation of these Official Rules, then such winner will be disqualified and an alternate winner may be selected from the remaining eligible entrants. No substitution or transfer of a prize is permitted except by The PrecisionPath Consortium.
